

CHAPTER 23

MANUFACTURED HOUSING CODE

ARTICLE I – GENERAL PROVISIONS

23-1-1 **DEFINITIONS.** The terms used in this Code shall have the following meanings:

"AFFIDAVIT" means an oath in writing, sworn before and attested by an individual who has authority to administer an oath.

"APPLICANT" means any person making application for a license or permit.

"CORPORATE AUTHORITIES" shall mean the Mayor and the Village Board of Trustees.

"IMMOBILIZED MANUFACTURED HOME": As applied to a manufactured home, "immobilize" means to remove the wheels, tongue and hitch and to affix to a permanent foundation. The term implies that, once affixed to a permanent foundation, the destruction of said foundation would be necessary in order to move the dwelling to another location.

"LICENSE" means a license certificate issued by the Village allowing a person to operate and maintain a mobile home park under the provisions of this Code and the rules and regulations issued hereunder.

"LICENSEE" means any person having a license or permit under this Chapter.

"MANUFACTURED HOME" means a structure designed for permanent habitation and so constructed as to permit its transport on wheels, temporarily or permanently attached to its frame, from the place of its construction to the location or subsequent location at which it is intended to be a permanent habitation and designed to permit the occupancy thereof as a dwelling place for **one (1)** or more persons. The term shall only include manufactured homes constructed after **June 30, 1976**, in accordance with the Federal **"National Manufactured Housing Construction and Safety Standards Act of 1974"**. Compliance with this standard is indicated by a 2-inch by 4-inch metal plate attached to the exterior tail light end of the manufactured home. The average width and/or length of the living area (excluding garages, carports, porches, or attachments) of a manufactured home shall not exceed a ratio of 3 to 1. As with all residences, a manufactured home shall have a minimum 4/12 pitch roof with residential style siding and roofing, **six (6) inch** minimum eave overhang, and shall have a minimum living area of not less than **nine hundred (900) square feet**. Provided that any such structure resting on a permanent foundation with wheels, tongue and hitch permanently removed shall not be construed as a **"manufactured home"**, but shall be an **"immobilized manufactured home"**. A manufactured home should not be confused with a **"camping trailer"** or **"recreational vehicle"**. **(See 210 ILCS 115/2.10)**

"MANUFACTURED HOME, DEPENDENT" means a manufactured home which does not have a toilet and bath or shower facilities. **(See 210 ILCS 115/2.3)**

"MANUFACTURED HOME, DOUBLE-WIDE" consists of **two (2) mobile units** joined at the side into a single home, but kept on their separate chassis for repeated transportation to a site.

"MANUFACTURED HOME, INDEPENDENT" means a manufactured home which has self-contained toilet and bath or shower facilities. **(See 210 ILCS 115/2.4)**

"MANUFACTURED HOME LOT" means a parcel of land for the placement of a manufactured home and the exclusive use of its occupants.

"MANUFACTURED HOME PAD" means that part of an individual manufactured home space or lot beneath the manufactured home, including the concrete portion of the pad.

"MANUFACTURED HOME PARK" means a tract of land or **two (2)** or more contiguous tracts of land upon which contain sites with the necessary utilities for **two (2)** or more independent manufactured homes for permanent habitation either free of charge or for revenue purposes, and shall include any building, structure, vehicle, or enclosure used or intended for use as a part of the equipment of such manufactured home park. Separate ownership of contiguous tracts of land shall not preclude the tracts of land from common licensure as a manufactured home park if they are maintained and operated jointly. Neither an immobilized manufactured home nor a motorized recreational vehicle shall be construed as being a part of a manufactured home park. **(See 210 ILCS 115/2.5)**

"MANUFACTURED HOME SALES AREA" means a parcel of land used for the display, sale, and repair of new or used manufactured homes.

"MANUFACTURED HOME SPACE" means a portion of a manufactured home park designed for the use or occupancy of **one (1) manufactured home**.

"MANUFACTURED HOUSING UNIT" includes all forms of housing units listed in this Section and as regulated in this Code.

"MOBILE HOME" means a structure designed for permanent habitation and so constructed as to permit its transport on wheels, temporarily or permanently attached to its frame, from the place of its construction to the location or subsequent location at which it is intended to be a permanent habitation and designed to permit the occupancy thereof as a dwelling place for **one (1)** or more persons. The term **"mobile home"** shall only include homes constructed prior to **June 30, 1976**, not in accordance with the Federal **"National Manufactured Housing Construction and Safety Standards Act of 1974"**.

"MODULAR HOME": A dwelling unit that is constructed in sections or modules at a manufacturing facility, transported to a building site, and assembled and permanently installed on a permanent foundation.

Modular homes are designed to meet or exceed the building codes adopted by the State of Illinois, including the Illinois Modular Dwelling and Mobile Structure Code (77 Ill. Adm. Code Part 880) and any applicable provisions of the Village of Bethalto Building Code.

Modular homes are not Manufactured (HUD-code) Homes or Mobile Homes, as those terms are defined by federal law as well as defined in this Code. Once installed on a permanent foundation, modular homes shall be considered equivalent to site-built homes for purposes of zoning, occupancy and taxation.

A modular home must bear an Illinois Department of Public Health (IDPH) certification seal indicating compliance with Illinois State modular dwelling standards. The home must be placed on a permanent, frost-protected foundation and connected to utilities in accordance with Village Building and Plumbing Codes.

(Ord. No. 2025-18; 12-08-25)

"OWNER" or "OPERATOR" means the licensee.

"PERMANENT FOUNDATION": A foundation which extends into the ground below the frost line so as to attach and become a part of the real estate. Materials such as concrete, mortared concrete block, poured wall or mortared brick extending into the ground below the frost line shall satisfy the requirement for a permanent foundation. In addition, piers may be used, extending into the ground below the frost line, and sufficient in number to properly support the structure, provided the support beams are affixed to the permanent perimeter foundation.

"PERMANENT HABITATION" means a period of **two (2) or more months**.

"PERMIT" means a certificate issued by the Building or Zoning Inspector, permitting the construction, alteration, or reduction in number of spaces of a manufactured home park under the provisions in this Code.

"PERSON" means any individual, group of individuals, association, trust, partnership, corporation, person doing business under an assumed name, county, municipality, the State of Illinois, or any political subdivision or department thereof or any other entity.

"REVOCATION" means to declare invalid a permit or license issued to the applicant or licensee by this Village for an indefinite period of time.

"SITE" means the lot on which the manufactured home is located for permanent habitation. **(See 210 ILCS 115/2.7)**

"SPACE" shall be synonymous with **"Manufactured Home Space"**.

"SUSPENSION" means to declare invalid a permit or license issued to the applicant or licensee by this Village for a temporary period of time with an expectation of resumption.

23-1-2 STATE REQUIREMENTS ADOPTED BY REFERENCE. The Illinois **Mobile Home Park Act** and the **Mobile Home Tiedown Act (77 Ill. Adm. Code 870)** of the **Illinois Compiled Statutes, Chapter 210, Section 115/1 et seq., as passed, approved and amended by the Illinois General Assembly** are hereby adopted by the Village. The applicable provisions as they pertain to manufactured homes and immobilized manufactured homes shall be controlling within the corporate limits of the Village.

23-1-3 MANUFACTURED HOUSING ACT ADOPTED. The **Illinois Manufactured Housing and Mobile Home Act, as passed and approved by the Illinois General Assembly** is hereby adopted by the Village, the applicable provisions as they pertain to manufactured homes and immobilized manufactured homes shall be controlling within the Village. **(See 430 ILCS 115/1 et seq.)**

23-1-4 ILLINOIS DEPARTMENT OF PUBLIC HEALTH ADOPTED AND REGULATIONS. The **Manufactured Home Community Code** as approved by the **Illinois Department of Public Health (1998)** is hereby adopted by the Village. The applicable provisions as they pertain to the Manufactured Home community shall be controlling within the corporate limits.

23-1-5 NATIONAL SAFETY STANDARDS. No manufactured home or immobilized manufactured home shall be located in the Village unless the unit has the **National Manufactured Housing Construction and Safety Standards** metal seal affixed thereto.

23-1-6 SKIRTING. Skirting shall be used to conceal all underpinning, plumbing, and support piers whether on a permanent foundation or otherwise. All skirting shall be installed on all manufactured housing units within **sixty (60) days** of the placement of the unit.

23-1-7 FIRE EXTINGUISHERS. All manufactured housing units located in the Village shall be equipped with a fire extinguishing apparatus capable of extinguishing all types of fires. Such extinguishers shall be of sufficient size so that they will reasonably protect the manufactured housing

units. All fire extinguishers shall be approved by the Fire Chief or his designated representative prior to installation of the manufactured home. **(See 425 ILCS 60/1-60/4)**

23-1-8 INSPECTION. All Manufactured Housing units located in the Village shall be subject to reasonable inspection by an official or officials designated by the Village Board.

23-1-9 OFF-STREET PARKING. Every owner of a manufactured housing unit shall provide for an off-street parking area of **four hundred (400) square feet.**

23-1-10 PROHIBITED RESIDENTIAL USES.
(A) **Dependent Mobile Home.** It shall be unlawful to locate a dependent mobile home in the Village unless placed in a state-licensed travel trailer park.
(B) **Independent Travel Trailer.** It shall be unlawful to reside in an independent travel trailer in the Municipality unless it is located in a state-licensed travel trailer park.
(C) **Manufactured Home.** It shall be unlawful to locate a manufactured home or a mobile home in a state-licensed travel trailer park without written permission of the Village Board or the Zoning Board.

23-1-11 CARBON MONOXIDE ALARM DETECTORS. Each unit shall be equipped with a carbon monoxide alarm detector as prescribed by state statute. **(See 430 ILCS 135/1 et seq.)**

23-1-12 SMOKE AND FIRE DETECTORS. Each unit shall be equipped with smoke and fire detectors as prescribed by state statute.

[NOTE: See Zoning Code Definitions.]

ARTICLE II - IMMOBILIZED MANUFACTURED HOMES

23-2-1 INSTALLATION CRITERIA.

(A) Each manufactured home space shall have a stand to provide adequate support for the placement and tie down of the manufactured home. The stand shall extend the length of the supports of the manufactured home, and shall consist of **four (4) inch** thick reinforced concrete slab.

(B) Each manufactured home shall be immobilized in a manner to meet or exceed the standards prescribed by the federal department of housing and urban development and any other requirements as prescribed by the Village.

(C) No manufactured home shall be immobilized, but anchors capable of withstanding a vertical tension force of **four thousand eight hundred (4,800) pounds** shall be installed at the corners of each stand or as otherwise necessary for protection against high winds. Every manufactured home shall be securely tied down to such anchors.

(D) The minimum first floor elevation shall be at least **eighteen (18) inches**, but not more than **thirty-six (36) inches**, above the crown of the nearest street or road.

(E) The frame, axles, wheels, crawl space area and utility connection of all manufactured homes shall be concealed from view through the use of durable all weather materials manufactured specifically for the purpose of covering the undercarriage area. Such skirting shall be fastened in accordance with manufacturer's instructions and shall provide adequate ventilation.

(F) All manufactured home spaces shall abut upon an all-weather surface driveway of not less than **twenty-one (21) feet** in width, which shall have unobstructed access to a Village street.

(G) Manufactured homes may only be placed in designated and approved manufactured home parks. Manufactured homes may not be placed in any zoning district other than RMH Residential Manufactured Home District. **(See Zoning Code)**

(H) To inhibit the spread of fire, no manufactured home shall be erected or placed within **fifteen (15) feet** of another manufactured home.

23-2-2 PERMIT - FEE. All persons seeking to locate or replace a manufactured home or an immobilized manufactured home outside a manufactured home park shall obtain a **Building or Zoning Permit** from the Village Clerk or Building Inspector. No utility services shall be connected to the unit until the Village has issued the appropriate permits. The fee to locate or relocate a manufactured home or immobilized manufactured home shall be **Twenty-Five Dollars (\$25.00)**. **(See Zoning Code for districts permitting these uses.)**

23-2-3 LOT SIZE. The minimum lot size for the location of an immobilized manufactured home shall be **eight thousand (8,000) square feet**. All immobilized manufactured homes shall be located in the Village, according to the requirements and restrictions of this Code. They shall not exceed **forty percent (40%) coverage** of the lot. **(See Section 40-3-9 in Zoning)**

23-2-4 CONCRETE PADS. All immobilized manufactured homes shall conform to the specifications for these units as provided in the definition in **Section 23-1-1**.

23-2-5 LIMIT OF UNITS. There shall be **only one (1)** immobilized manufactured home per lot in the Village.

[NOTE: See Section 23-1-9 for parking requirements.]

ARTICLE III - MANUFACTURED HOME PARKS

DIVISION I - ADMINISTRATION REQUIREMENTS

23-3-1 COMPLIANCE WITH STATUTES, APPLICABILITY OF ARTICLE. Every manufactured home park hereafter established in the Village shall, at a minimum, conform to the requirements of:

(A) The Illinois **Mobile Home Park Act** and the **Mobile Home Tiedown Act (77 Ill. Adm. Code 870)** of the **Illinois Compiled Statutes, Chapter 210, Section 115/1 et seq., as passed, approved and amended by the Illinois General Assembly** are hereby adopted by the Village. The applicable provisions as they pertain to manufactured homes and immobilized manufactured homes shall be controlling within the corporate limits of the Village.

(B) The **Manufactured Home Community Code** as approved by the **Illinois Department of Public Health (1998)** is hereby adopted by the Village. The applicable provisions as they pertain to Manufactured Home community shall be controlling within the corporate limits.

(C) **This Code.**

(D) **Zoning Code.**

In case of conflict between any provisions of the above, the more stringent requirement shall prevail.

23-3-2 PERMITTING AND PLANNING A PARK. Any person seeking to establish, operate, alter, or expand a manufactured home park shall obtain a permit to construct or a license to operate a manufactured home park.

"Construct or operate a manufactured home park", as used in this Code shall include, but not necessarily be limited to supplying or maintaining common water, sewer, or other utility supplies or services, or the collection of rents directly or indirectly from **two (2)** or more independent manufactured homes. **(All plans shall be submitted to the Zoning Board for approval prior to the granting of a permit.)**

23-3-3 LOCAL GOVERNMENT REQUIREMENTS. A permit does not relieve the applicant from complying with this Code or other ordinances applicable thereto.

23-3-4 PERMITS. The Plan Commission or the Village Board shall review each application and plan documents submitted. When the application and plan documents are found to be in compliance with the **"Manufactured Home Community Code"**, as approved by the **Illinois Department of Public Health**, the Village Board or its designee may issue the proper permit to construct or alter a manufactured home park to the applicant. Permits shall be valid for **one (1) year from date of issue.**

23-3-5 INSPECTION OF MANUFACTURED HOME PARK. Upon completion of the proposed construction of a manufactured home park or the proposed alteration of a manufactured home park, the applicant shall notify the Village or the designated official in order that an inspection of the complete facilities can be made.

23-3-6 VIOLATION PROCEEDINGS. Any license granted hereunder shall be subject to revocation or suspension by the Mayor. However, the Mayor or his representative shall first serve or cause to be served upon the licensee a written notice in which shall be specified the way or ways in which such licensee has failed to comply with the statutes, or any rules or regulations promulgated by the Village pertaining thereto. The notice shall require the licensee to remove or abate such nuisance,

unsanitary or objectionable condition, specified in such notice within **five (5) days** or within a longer period of time as may be allowed by the Village Board. If the licensee fails to comply with the terms and conditions of the notice within the time specified or such extended period of time, the Mayor or his representative may revoke or suspend such license.

23-3-7 INITIAL PERMIT REQUIRED. Each manufactured home that locates on a lot in a manufactured home park shall secure an initial Building or Zoning Permit from the Village. All future locations on the same lot shall be exempt from the fee. **(See Zoning Code)**

23-3-8 SAFETY STANDARDS. From and after **October 1, 2015**, no manufactured home or immobilized manufactured home shall be located in the Village unless the unit has the National Manufactured Housing Construction and Safety Standards metal seal affixed thereto.

23-3-9 MANUFACTURED HOME PARK STANDARDS.

(A) **Water Requirements.** An adequate water supply of safe, sanitary quality approved by the Illinois Department of Public Health shall be furnished within each recreational vehicle facility or manufactured home court. At least one cold water supply outlet shall be provided for each recreational vehicle or manufactured home.

(B) All sewage and other water carried wastes shall be disposed of into the Village sewerage system. If the Village sewers are not available, disposal shall be into a private system which includes a sanitary means of disposal, the operation of which creates neither a nuisance nor a menace to health.

When a water carriage of sewage is used, each recreational vehicle or manufactured home site shall be provided with a sewer connection for the combined liquid waste outlet or outlets of each recreational vehicle or manufactured home, and trapped below the front line. It shall be the duty of the owner or operator of each recreational vehicle facility or manufactured home court to provide an approved type of water and odor tight connection from the recreational vehicle or manufactured home drainage to the sewer connection and it shall be the duty of said owner or operator to make such connection and keep all occupied recreational vehicles or manufactured homes connected to said sewer while located in the recreational vehicle facility or manufactured home court. Sewer connections in unoccupied recreational vehicle or manufactured home sites shall be closed so that they will emit no odors or cause a breeding place for flies. No water or waste shall be allowed to fall on the ground from any recreational vehicle or manufactured home.

Prior to the connection or reconnection of any recreational vehicle or manufactured home to the public sewer or a lateral leading to the public sewer, a permit shall be required. The application for a permit as required herein shall be on a form to be provided by the public works department and an application fee of **Twenty-Five Dollars (\$25.00)** shall be required to be paid to the Village prior to the issuance of the permit. Prior to backfilling and/or connection of any pipe or appurtenances thereto, the public works department shall cause a physical inspection to be made of each recreational vehicle or manufactured home connection to the public sewer or to the lateral connecting to the public sewer system of the Village to assure that the connection is water and odor tight and otherwise fully in compliance with the requirements of the Village.

(C) It shall be the duty of the owner or operator of any recreational vehicle facility or manufactured home park to provide adequately maintained outdoor lighting at all times so that the grounds will be safe for occupants and visitors.

(D) **Trash Regulations.** Each manufactured home within a manufactured home park shall be required to comply with the ordinances of the Village pertaining to trash and refuse disposal, including the payment of a monthly refuse fee as required by Village Code. The owner or operator of any recreational vehicle facility shall be required to provide for the collection and removal of garbage or trash or other waste material and to otherwise maintain a recreational vehicle facility in a thoroughly clean and sanitary condition.

23-3-10 **CONNECTION TO PERMANENT UTILITIES.** No manufactured home shall remain in a manufactured home district for a period exceeding **fifteen (15) days** without connection o permanent utilities.

23-3-11 **DANGEROUS MANUFACTURED HOMES PROHIBITED.** No manufactured home constructed prior to **June 30, 1976** nor any manufactured home not constructed in compliance with the federal "National Manufactured Housing Construction Safety Standard of 1974" nor any manufactured home which is deemed by the Zoning Administrator to be a hazard to the public health or safety shall be moved into, erected or installed in the Village.

[NOTE: See Section 23-1-9 for parking requirements.]

23-3-12 - 23-3-19 **RESERVED.**

DIVISION II - DESIGN AND CONSTRUCTION REQUIREMENTS

23-3-20 **PLAN DOCUMENT.** In order to obtain a permit to construct or an original license to operate a manufactured home park, the applicant shall file with the Village a written application and plan documents and such plan documents shall be prepared by a registered engineer or architect licensed to practice in the State of Illinois, with registration seal affixed. **Two (2) copies** of the plan document shall accompany the application filed with the Village Clerk to obtain a permit to construct or alter a manufactured home park or an original license to operate a manufactured home park, not previously licensed by the Department. These plans shall include, but not be limited to the design and construction criteria set forth herein. **[If there is a Zoning Administrator then the plans should be filed with that office.]**

23-3-21 **APPLICATION.**
(A) Every applicant shall file with the Village Clerk a written application and plan documents for the proposed construction or alteration of a manufactured home park.

(B) The application shall be completed by the applicant and the engineer or architect and shall include:

- (1) The full name and address of the applicant or applicants, or names and addresses of the partners if the applicant is a partnership, or the names and addresses of the officers if the applicant is a corporation, and the present or last occupation of the applicant at the time of the filing of the application. If the applicant is a corporation, a copy of the certificate of incorporation must be filed with the application.
- (2) The proposed method of lighting the structures and land upon which the manufactured home park is to be located.
- (3) The plot plans of the manufactured home park, building plans and specifications for existing buildings and facilities, and the plans and specifications for new buildings and facilities or the proposed alterations in existing facilities.
- (4) An affidavit of the applicant as to the truth of the matters contained in the application shall be attached.

- (5) Each application shall be accompanied by an application fee of **Three Hundred Dollars (\$300.00)** for a permit to construct, or an application fee of **One Hundred Fifty Dollars (\$150.00)** for a permit to alter to increase the size of the park.

23-3-22 LOCATION.

(A) Sites selected for manufactured home development shall be well-drained and free from topographical or geological hinderances and from other conditions unfavorable to a proper residential environment. The manufactured home development shall not be located near swamps, wetlands, marshes, or other breeding places of insects, rats, mice or other rodents. When a good, natural drainage is not available, storm water drainage shall be provided and such drainage shall not endanger any water supply or surface watercourse.

(B) The Village Board may authorize a site survey to ascertain that the proposed location complies with the above requirements. **(See Flood Plain and Zoning Codes, if any.)**

23-3-23 ROADWAYS AND PARKING.

(A) All streets and driveways in every park shall be constructed in compliance with the Subdivision Code in **Chapter 34.**

(B) All streets in parks constructed shall have a minimum right-of-way of **fifty (50) feet** and a minimum road width of **thirty-two (32) feet** for the purpose of this Code, and shall be considered private streets to be maintained by the park owner or operator.

If a manufactured home park has more than **fifty (50) units**, a wider street may be required by the corporate authorities.

(C) Sidewalks and walkways shall be constructed abutting a street in a manufactured home park and shall be a minimum of **four (4) feet** in width; provided, however, there shall be no minimum width requirement for sidewalks for each individual lot. No portion of a mobile home shall block, in any way, the pedestrian traffic on the walkways.

23-3-24 - 23-3-26 RESERVED.

DIVISION III - GENERALLY

23-3-27 LOT SIZE. The minimum lot size for a manufactured home pad shall be **eight thousand (8,000) square feet**, with a minimum frontage of **fifty (50) feet**.

23-3-28 MISCELLANEOUS RESTRICTIONS.

(A) No manufactured home unit parked in a manufactured home park shall be immobilized.

(B) Not more than **one (1) manufactured home unit** shall be parked in **one (1)** space.

(C) No travel-trailer shall be permitted in any manufactured home park, unless a special area has been approved for that purpose by the Zoning Board.

23-3-29 - 23-3-30 RESERVED.

DIVISION IV - FEES

23-3-31 **LICENSE FEE.** The annual license fee per manufactured home park shall be **Ten Dollars (\$10.00)**, and shall be due and payable **on or before May 1st of each year.** The Village Clerk shall notify the owner or operator of the annual fee at least **thirty (30) days** prior to **May 1st.**

ARTICLE IV – MODULAR HOME CONSTRUCTION STANDARDS

23-4-1 **COMPLIANCE WITH STATUTES, APPLICABILITY OF ARTICLE.** Every modular home constructed and installed within the Village shall, at a minimum, conform to the requirements of:

(A) **The Illinois Modular Dwelling and Mobile Structure Safety Act**, Section 430, Chapter 115/1 *et seq.*, as passed, approved and amended by the Illinois General Assembly, is hereby adopted by the Village. The applicable provisions as they pertain to modular homes and their construction standards shall be controlling within the corporate limits of the Village;

(B) **The International Code Council (ICC) and Modular Building Institute (MBI) Standards for Off-Site Construction.** Inspection and Regulatory Compliance, which establishes minimum requirements for inspection and code compliance of off-site construction components, specifically cited at ICC/MBI 1205/2021, are hereby adopted by the Village. The applicable provisions as they pertain to Modular Homes and Construction Standards shall be controlling within the corporate limits. These provisions shall apply to all off-site and modular construction, including residential, commercial, and institutional structures, within the Village of Bethalto. Copies of this standard shall be maintained on file in the office of the Village Clerk and made available for public inspection;

(C) This Village of Bethalto Municipal Code; and

(D) The Village of Bethalto Zoning Code.

23-4-2 **SCOPE AND APPLICATION.**

(A) Modular home construction is permitted within the following Single Family Dwelling Districts as noted within the Village of Bethalto Zoning Code:

AG – Agricultural District

RS-20 – Single Family Residential

RS-8 – Single Family Residential

RS-5 – Single Family Residential

RT – Two Family Residential

RM – Multiple Family Residential

(B) Any modular home which is placed on a lot in any of these districts must meet all the regulations given for the district.

(C) Any modular home that is manufactured at a factory without the installation of the utilities such as plumbing, electrical and heating systems are subject to the same local regulations as a site-built house.

23-4-3 **INSPECTION OF COMPONENT CONSTRUCTION.**

(A) **Authority.** The Village Building Official, or their designee, shall have authority to oversee inspections of off-site construction in accordance with ICC/MBI 1205-2021.

(B) **Third Party Inspections.** The Village Building Official, or Village designee, may accept inspection reports from qualified third-party agencies or remote virtual inspections (RVI), provided such inspections meet the criteria set forth in ICC/MBI 1205-2021.

(C) **Verification of Components.** Prior to installation at the final building site, all off-site construction components must receive verification of compliance by the Village or a Village-approved third-party inspection agency.

23-4-4 **PERMITS AND DOCUMENTATION.**

(A) No building permit shall be issued for the installation of off-site or modular construction components until evidence of compliance with ICC/MBI 1205-2021 has been submitted and approved by the Village Building Official or Village designee (see above).

(B) Documentation shall include, but is not limited to, the Village Building Permit Application, factory inspection reports, certification of compliance, test results, and any other documentation required under the ICC/MBI 1205-2021 standard.

(C) The Village Building Official, or Village designee, shall review each application and modular home plan documents submitted. When the application and modular home plan documents are found to be in compliance with the ICC/MBI standards as well as the Illinois Modular Dwelling and Mobile Structure Safety Act, the Village Board or its designee may issue the proper permit to construct a modular home to the applicant. Permits shall be valid for **one (1) year from date of issue**.

23-4-5 ENFORCEMENT. Any violation of this Article shall be subject to the penalties and remedies provided in the Code of Ordinances and Zoning Code, to include stop-work orders, fines and/or revocation of building permits.
